I/we certify that I/we am currently or will be residing in the above residence for a period of six (6) months after completion of installation and/or changes as per the permit(s).

I/we further certify that I/we am/are familiar with the provisions of the applicable Ordinance(s) and the rules governing the type of installation and/or construction which is contemplated at the above residential address, and hereby agree to make installation and/or construction in conformance with the Ordinance(s).

In making this application, I realize that I/we am/are assuming the responsibility of a licensed contractor for the installation and/or construction of the work as per the permit application(s), and for the placing of equipment or materials for the purpose of installing and/or constructing any portion of work covered by the homeowner's permit. I/we will not sub-contract to any other person, firm or corporation for work that is covered by the homeowner's permit(s).

I agree to notify the City Department(s) which the permit(s) cover(s) within seventy-two (72) hours after installation and/or construction is completed and is ready for service, so that the required inspection(s) may be made. I / we further agree to keep all parts of the installation and/or construction exposed until the work is accepted as being in compliance with Ordinance requirements.

I further agree to correct, within two (2) week's time, any violations on the installed and/or constructed work and to provide access to the premises between the hours of 8:30 a.m. and 3:30 p.m., Monday through Thursday, for the necessary inspection(s).

Failure to complete the work per the permit(s); to provide access to the work; and/or to correct work requiring a licensed contractor to complete the necessary work could result in Notices of Violation and/or tickets.
