GENERAL: Plumbing work shall not be started until the Plumbing Permit has been issued by the City of Ferndale. All installations shall be in conformance with the State Plumbing Code. No work shall be concealed until it has been inspected. When ready for inspection, contact (248) 546-2366 Monday – Thursday, 8 AM to 5:30 PM. The address, permit number and type of inspection are required when requesting an inspection.  EXPIRATION OF PERMIT: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work does not complete a final inspection within one year from the date of issue. CANCELED PERMITS CANNOT BE REFUNDED OR REINSTATED.  THIS APPLICATION, WHEN PROPERLY NUMBERED AND SIGNED, BECOMES A PERMIT. AS SUCH, IT CONVEYS NO RIGHT TO CONCEAL PIPING, EITHER TEMPORARILY OR PERMANATELY – BEFORE APPROVAL. IT IS HEREBY UNDERSTOOD AND AGREED THAT THIS PERMIT IS GRANTED ON THE EXPRESS CONDITION THAT THE SAID CONSTRUCTION SHALL CONFORM TO THE ORDINANCES OF THE CITY OF FERNDALE REGULATING THE CONSTRUCTION OF BUILDINGS AND MAY BE REVOKED UPON THE VIOLATION OF SAID ORDINANCES.  SECTION 23A OF THE STATE CONSTRUCTION CODE ACT OF 1972, 1972 PA 230, MCL 125.1523A, PROHIBITS A PERSON FROM CONSPIRING TO CIRCUMVENT THE LICENSING REQUIREMENTS OF THIS STATE RELATING TO PERSONS WHO ARE TO PERFORM WORK ON A RESIDENTIAL BUILDING OR A RESIDENTIAL STRUCTURE.
